Art. 1. Subject

- 1.1 The purpose of this contract is to provide the educational offer of the **first year** of the two-year veterinary nursing online education course held and managed by ABIVET S.r.l. whose programme is indicated in *Annex A - Programme and prices*.
- 1.2 The completion of the theoretical courses and the attendance at the Curricular Internship are required to the minimum extent indicated in *Annex B - Course regulations*.

Art. 2. Admission requirements

- 2.1 Are admitted to attend the education course those who:
- have a graduation from secondary school;
 - have sent by registered letter with return receipt or delivered by hand at the office of ABIVET S.r.l. - all the following documents: i) the present contract duly signed in duplicate; (ii) self-declaration of the studies; (iii) copy of a valid identity card and the social security number; (iv) acknowledgement and acceptance of the privacy policy; (v) payment receipt of the 1st module of the course;
 - have actually paid ABIVET S.r.l. for the amount related for the first module of the course;
 - foreign students must add a valid residence permit to the above documentation.

Art. 3. Course fees

- 3.1 The cost for the first year of the course is Euro 2,440.00 (VAT rate of 22% included), to be paid in several tranches upon purchase the different modules, according to what is indicated in more details in Annex A. It is understood that, in case of increased VAT rate, the overall cost of the course will be consequently increased.
- 3.2 Payment of the amounts due to ABIVET S.r.l. can be made:
- by money order or bank transfer, to routing number indicated on the website <http://www.vetnurselearning.com/en/enrolment-fees/> (indicating **CAUSAL: **PAYMENT MODULE NAME + STUDENT NAME AND SURNAME****); once the payment has been made, it is necessary to send the receipt by e-mail to romainfocorsi@abivet.org;
 - by paypal or credit card, using the link provided on the website <http://www.vetnurselearning.com/en/enrolment-fees/>, expected only for the payment of the first module of the first year.


Art. 4. Pre-contractual information

- 4.1 The student declares to have read, before signing this contract, all the information related to the course contained in the official website of ABIVET S.r.l. and from which the main characteristics of the services provided by ABIVET S.r.l. are obvious, the geographical address and the identity of ABIVET S.r.l. (provider of the services referred to this contract).

Art. 5 Right of withdrawal and surrender

- 5.1 In the event that the contract is concluded between remote parts (without the physical and simultaneous presence of the parts), the student agrees knowingly and expressly to lose any right of withdrawal from this contract, applying the exceptions to the right of withdrawal under 'Art. 59, c.1 letter. a) and o) of Legislative Decree 6 September 2005 n.206 (Consumer Code).

Actually, by purchasing this e-learning mode course, the student agrees on the provision of digital learning objects through a non-material support, with the express agreement and acceptance that this circumstance precludes any right of withdrawal. In addition, the student agrees to lose his right of withdrawal from this service, since it was made accessible and usable to the user through the access to the online platform of ABIVET S.r.l.

5.2 After the course registration has been completed, if the student does not take exams related to the modules for a period exceeding six months, he will be automatically cancelled from the platform with the exclusion of any right to a refund of the amounts already paid to ABIVET S.r.l. for the modules purchased.

5.3 In the event that the student decides to give up the course attendance, he must notify ABIVET S.r.l. by registered letter with return receipt to the address ABIVET SRL - VIA GENNARGENTU 20 00141 - Rome. It is understood that, in this case, the student will not be entitled to a refund of the amounts paid for the modules purchased before the date of submission of the communication of surrender.

Art. 6. Exams

6.1 To the purchase of each module, the student will have to take, within three months, an exam; the passing of the exam will allow the continuation of the course of study. It is understood that, upon expiry of this period, the student will have to complete from the beginning the module, before to have the chance to take the relative exam again.

6.2 The only exam that happens at the headquarters of ABIVET S.r.l. will be the final exam of the second year of the course.

Art. 7. Final exam - Issue of certification


7.1 The student expressly recognizes that the certification of competence for veterinary nurse will be issued only after passing the final exam of the second year of the two-year education course, which can be accessed only after having passed all the exams related to the each module of the first and second year of the course and completed the hours of the Curricular Internship.

7.1 The student also acknowledges that registration to the second year of the education course is also subject to the issuance of a positive opinion by the didactic direction of ABIVET S.r.l.

Art. 8. Change of programme

8.1 The student expressly acknowledges that ABIVET S.r.l. may change the course programme (total number of theoretical sections and training period) without substantially altering its contents and structure.

Art. 9. Course regulations

9.1 The student will be required to respect the course internal regulations attached in the *Annex B - Course regulations*. It is understood that, in case of violation of the rules, the student can be expelled from the course without being entitled to a refund of the amounts paid on the purchase of modules.

Art. 10. Duration of the contract - Termination Clause

10.1 This contract will have a duration of 24 months starting: i) in case of its subscription at the headquarters of ABIVET S.r.l., from the date of the subscription; ii) in the case of its remote conclusion, from the date on which ABIVET S.r.l. receives the documentation referred to Article 1 above and, at the end of this period, the contract will cease to be effective.

10.2 ABIVET S.r.l. has the right to terminate this contract in accordance with Article 1456 of the Italian Civil Code, upon simple notice and without prejudice, in any case, its right to a compensation for any damage suffered - in all cases expressly provided for in this contract including:

- if the student is guilty of fraud and/or gross negligence in the execution of this contract;
- if the student is defaulting to even one of the obligations established under Article 1 letter a; b; c; d; e; f; g of Annex B - Course regulations.

Art. 11. Disputes

11.1 In the event of disputes - except in the event that mandatory rules of law apply (including the Consumer Code) - will be responsible exclusively to the Court of Rome.

ANNEX B – COURSE REGULATIONS

Art. 1. Code of conduct

- a. the student is required to adopt a correct behaviour and appropriate language, in relations with teachers, tutors and other registered members of the Learning Platform, as well as during the Curricular Internship;
- b. the student can print out the downloadable contents of the Learning Platform only for personal study purposes and not for commercial purposes;
- c. the student cannot use the contents of the Learning Platform for purposes other than personal study purposes;
- d. the student cannot send or transmit through the Learning Platform software or content that violates the rights of third parties;
- e. the student must adopt appropriate attire, which must conform to the seriousness and professionalism of the working places where he will perform the Curricular Internship;
- f. the student, during the theoretical study and the Curricular Internship, must refrain from publishing videos and photos, as well as from any kind of dissemination to the public (including publishing online and sharing on his social network profile);
- g. ABIVET S.r.l., who is responsible for the courses, reserves the right to remove immediately, at his own unquestionable judgement and without any refund, any student who may have behaved in a way that is prejudicial to the dignity and safety of others, or who has caused damage to structures, things or animals.
- h. the student, independently of his progress and profit of the theoretical study and of the Curricular Internship observations, must refrain from proposing or advertising consultancy or services of Veterinary Medical competence, independently of whether free or paid, and must refrain from using the name of ABIVET in this illegal activity;

Art. 2. Learning materials and verification tests

- a. final tests are mandatory for each subject of each module purchased;
- b. if the student does not complete the entire education course, including the 1st year Final Exam, the 2nd year registration will not be allowed.


Art. 3. 1st Year Final Exam

- a. at the end of the first year of the education course, there is a verification test regarding all the subjects of the first year, for which the sufficiency is reached with a score of 60/100, according to the evaluation criteria communicated with adequate notice;
- b. starting with the minimum score of 60/100, the student will acquire credits (for a maximum of 3), which can be add to the theoretical test of the Final Exam of the 2nd year.

Art. 4. Admission requirements to the Curricular Internship

- a. before the beginning of the internship, the student must present a medical certificate of strong and healthy fitness and the certification relating to tetanus vaccination;
- b. female student, in case of pregnancy, within two months from the beginning of the pregnancy, in order to adopt precautionary measures to safeguard the unborn child, must

present the appropriate certificate, due to the particular activity in contact with animals and radiological equipment;

- c. ABIVET S.r.l. declines any possible responsibility deriving from the non-observance of what has been defined above.

- a. The student must have completed 100% of all the mandatory hours required for the Curricular Internship, in order to be admitted to the 2nd year of the course;
- b. absences due to illness must be proved by a medical certificate and recovered.
